The Ohio Department of Transportation (ODOT) Construction and Materials Specifications (CMS) Manual requires that, with exception to those used for parking, all areas outside the project work limits be reviewed to evaluate potential impacts to cultural and ecological resources, public lands, FEMA 100-year floodplain and hazardous waste materials. The selected contractor is required to contract with an environmental consultant pre-qualified by ODOT for each environmental resource to be evaluated.

*Section 105.16* "...Have the proposed borrow and waste areas reviewed by an environmental consultant that is pre-qualified by the Department for ecological work."

*Section 107.10* "...All properties to be utilized by the Contractor outside the project work limits must be cleared for all environmental resource impacts prior to the beginning of work."
